

#### ADMINISTRATIVE MATTERS

Commission President Joe Gardner welcomed all and called the meeting to order. President Gardner announced that meetings are recorded and asked that everyone identify themselves prior to addressing the Commission.

  - a. Public Safety Concerns (DJJ ages goes to age 25)
  - b. Custody management (Need to increase training from current BCSC Juvenile Core Course?)
  - c. Field Supervision (Similar to how PCRS/AB109 is done or like currently done by Juvenile Field Services?)
  - d. Fiscal Impact (any state reimbursement? Cost to county? Revenue source?)
  - e. Facility needs (Upgrades for handling a higher risk population)
  - f. Anticipated numbers 70+- as stated by Deputy Director Cotton on 6-11-2020
  - g. Types of offenses (Usually very serious) Top three DJJ percentages and numbers
  - h. Mental Health issues
  - i. Alternatives to incarceration
- •SB 889 (Proposed legislation changing minors to youth
  - a. Makes Juvenile prosecution and juvenile 19 and under
  - b. How to use facilities to keep 18+ separate from those 17 and under
  - c. Fiscal Impact due to adding 18 and 19-year-old the Juvenile System, (any state reimbursement? Cost to county? Revenue source?) Education planning for new youth high school diplomas for those who have not gotten already; college courses for others.
- •Community service providers that they are working with to provide services both within the facilities, and once youth are released:
  - a. Job training/placement.
  - b. Mental health support.
  - c. Drug and alcohol support.
  - d. General re-entry preparation.
- Family counseling

Jennifer Kaufman, RTSB Bureau Chief, reported the following:

- On June 15, 2020 staff at Dorothy Kirby Center tested positive for COVID-19
- The Garrett cottage was quarantined; all youth and staff were tested
- Seven youth tested positive but six were A-symptomatic
- Three staff and two youth tested positive at the Agua cottage
- The Aqua cottage has been medically isolated, and temperatures are being checked twice a day
- On June 16, 2020 a staff tested positive for COVID-19 at Camp Rocky
- The Camp was placed on quarantine and temperatures are being taken twice a day

Mark Garcia, DSB Bureau Chief, provided the following updates:

- Several pathways (Microsoft Teams, WebEx, Google duo etc.) are currently being used to virtually connect the youth with the community programs.
- In conjunction with judicial partners the BlueBox system has been reinstated to allow the youth to virtually connect with their attorneys.
- Virtual Court is still processing 30 cases per day

- Courts soft reopened on June 22<sup>nd</sup>, 2020; however, 98% of cases are still done virtually
- 30 to 40 youth are connecting virtually with their parents on a weekly basis
- The Probation Department is working with Public Health in developing guidelines to physically reopen and allow parents and community members back into the facilities
- Proposed guidelines are currently under review
- Virtual church services are streaming live
- Telemedicine 19 workstations have been installed throughout the facilities; allowing doctors and nurses to be connected 24/7
- Telehealth installed DMH installed workstations throughout the facilities and were live on June 1, 2020

Robert Smythe, Administrative Deputy, provided a summary on budgetary curtailments and DJJ updates:

- 8% curtailment to Net County Cost
  - 44 million and 274 positions (vacant)
- Realignment of AB109
  - 11.5 million and 78 positions (vacant)
- Probation will be preparing a Supplemental Budget (due in September) intended to address unknown budgetary needs
- DJJ is planning on stopping acceptance of new youth in January 2021 and will attrition out as youth complete their programs
- Youth who attrition out will most likely be serviced by Field supervision
- Confirmation of funding amount to Counties or Probation is still unknown

Sheila Mitchell, Deputy Chief, also added the following regarding DJJ:

- DJJ is still going through the legislative process but is not part of Assembly Bill 88 and 181 (Public Safety Bill) as of yet
- A subcommittee has been formed to realign the DJJ work, including finding local community-based programs and housing in our open facilities

Tom Faust, Chief of Staff stated the following:

- Construction at Campus Gonzalez is currently on hold while budgetary alignments are being reviewed
- Ms. Mitchell as added that Brandon Nichols, Chief Deputy, is now the lead on the Gonzalez project
- Plans to transfer youth back to Campus Kilpatrick are still on schedule once repairs have been completed

#### LOS ANGELES COUNTY DEPARTMENT OF MENTAL HEALTH

Discussion with Director of the Los Angeles County Department of Mental Health, Dr. Jonathan E. Sherin regarding refining the approach to enhance safety within Probation Department facilities and improve the care of minors suffering from forms of mental illness.
